- 凡參加2009年本會舉辦以下的歐美展覽的會員商號將可獲參展費回贈：

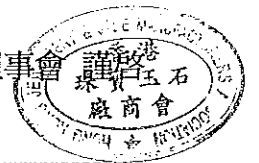

**A Must-read for Members !**

Following the fast weakening of the US economy, Europe has also headed into recession. The financial tsunami that beset the whole world has spread from institutions to the public, and has even extended to Hong Kong. The jewellery industry, which cannot escape from being affected, is under heavy pressure such as bad debits, goods return and outstanding credit bills. In such change-ridden situations, coupled with market uncertainties, our Association is determined to weather the storm together with all the Members. With this in mind, the Council of Management has immediately passed the following scheme with a bid to offer assistance to Members as best as possible so that all can bravely face the predicament.

The scheme passed by the Council of Management is the allocation of a maximum of HK\$3,000,000 for the following items:

- Exemption of 2009 Membership Fee for Full Members, Associate Members and Corporate Members.
- Even if fair organizers or booth contractors raise their fees, the Association will freeze the participation fees for 2009 shows held in Europe and the U.S.
- Members participating in the following Vicenza and US Shows in 2009 will be entitled to a rebate on the participation fee:
